"Temporary / Itinerant Vendor Fee Schedule. On and after the effective date of the ordinance codified in this chapter, there is hereby levied upon and shall be collected from every temporary business, itinerant vendor, stationary vendor, mobile vendor, door-to-door sales and/or concessionaire conducting business within the City of Wenatchee a temporary license fee for the privilege of engaging in temporary business activity. Such temporary license fee is fixed in the amount of \$50.00 for a period of 30 days, or \$25.00 for a period of three days, payable in advance, and will automatically expire at the end of the period. Any consessionaire conducting business beyond the 30-day period will be required to obtain a permanent license. Temporary licensee must supply a copy of owners permission for use of their property (Ord. 361 ss 1, 1996; Ord. 3062 ss 8,1994)"

The following are exempt from the provisions of this chapter

(7) Any person in respect to the business of conducting boxing contest and sparring and/or wrestling matches and exhibitions for the conduct of which a license must be secured from the State Athletic Commission.
